EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF COMPANIES ACT, 2013

Mr. Sandeep Ghosh (PAN: AFAPG3672B) was appointed as Manager of the Company by the Board of Directors of the Company vide its meeting held on 10th August, 2023 for a period of 5 years from 2nd August, 2023 upto 1st August, 2028 and the said appointment was duly approved by the members of the Company on 30th October 2023.

The Board of Directors in its meeting held on 14th November 2024 decided to remove Mr. Sandeep Ghosh (PAN: AFAPG3672B), as Manager of the Company with effect from the closing of business hours on Friday, 4th October 2024 as his performance was not found satisfactory to the expectations of the management. Further, as approval for appointment was confirmed by the members of the Company, it was found prudent to get the resolution for his removal also approved, ratified and confirmed by the members of the Company.
